

# terms and conditions of use of the mgic websites

**Important Notice Regarding Use of this Site:** This website and all other MGIC websites (collectively, the "Site") are provided for use by Mortgage Guaranty Insurance Corporation, its affiliates and parent corporation (collectively, "MGIC") subject to the following terms and conditions ("Terms"). Your use of this Site constitutes your agreement to the Terms. The terms "you" and "your" mean the individual user of the Site and any entity on whose behalf such user accesses the Site.

Any attempted unauthorized use of or access to this Site is strictly prohibited and may result in criminal and/or civil prosecution.
